TERMS & POLICIES

WHOLESALE OVERVIEW

SZN'D SAVORS offers small-batch seasoned oils and spice blends crafted for specialty retail, gourmet shops, and curated food spaces. Each product is produced in limited batches to support freshness, consistency, and flavor integrity.

MINIMUM ORDER REQUIREMENT

Initial Opening Order: \$200 minimum. Reorder minimum: \$100. Case packs may apply depending on SKU availability.

PRICING & PAYMENT TERMS

SZN'D SAVORS reserves the right to adjust wholesale pricing when necessary to reflect significant changes in tariffs, ingredient or packaging costs, transportation expenses, or broader economic conditions. Retail partners will be given reasonable advance notice of any pricing changes whenever practicable. **Existing confirmed orders** will be honored at the pricing agreed upon at the time of order. Payment is required prior to shipment of minimum quantity required. Accepted methods include credit/debit card, ACH, or approved invoicing platforms. Net 15 terms offered to established retail partners.

ORDERING PROCESS

Retail partners may place orders by email purchase order, wholesale intake form, or direct invoice link via website: www.szndsavors.com. Orders are confirmed within 24.

FULFILLMENT & LEAD TIME

Standard processing: 3 - 7 business days. Seasonal or larger orders: 7 - 14 business days. Because products are prepared in small batches, timelines may vary slightly according to production cycles.



SHIPPING

Shipping is calculated based on order size and destination. Orders are shipped via tracked carriers. Retailers are responsible for providing accurate delivery details. SZN'D SAVORS is not responsible for carrier delays.

RETURNS & DAMAGES

Due to the nature of food products, all sales are final. Damaged or incorrect items must be reported within 5 business days of delivery. Photo documentation may be requested. Approved issues will be replaced or credited on a case-by-case basis.

STORAGE & HANDLING

Store in a cool, dry place away from direct sunlight. Refrigeration is not required unless specifically stated on a product. Follow the labeled shelf-life guidance for optimal flavor quality.

BRAND PRESENTATION

Retail partners are asked to maintain product integrity and upright display and to avoid excessive heat or direct sunlight. Sell sheets, pairing guides, shelf talkers, and product cards may be available upon request.

TERRITORY & EXCLUSIVITY

Exclusivity may be offered for select regions or accounts. Exclusivity is not guaranteed and must be discussed and agreed upon prior to any arrangement.
